

SUPER CHEF **LIMITED WARRANTY**

Super Chef Corporation (“Super Chef”) warrants to the original purchaser component parts used in the manufacture of its equipment to be free from defects and workmanship and material for a period of one (1) year from date of original purchase under normal use and service. Under this Limited Warranty, Super Chef’s liability is limited to repair or replacement of component parts and/or equipment determined by Super Chef to be defective. In such event, Super Chef shall have the option to either repair or replace at its factory or on user’s premises any component parts or equipment which are determined by Super Chef to be defective or to authorize a qualified Super Chef equipment servicer to repair or replace such component parts or equipment. In the event that Super Chef chooses to authorize the use of a qualified equipment servicer, Super Chef’s entire liability hereunder shall be to repair or replacement of defective component parts and/or equipment and the reasonable cost of labor to perform such repairs and/or replacement. Super Chef shall not be responsible for travel charges, travel time, cartage, freight, adjustments or normal cleaning. **THIS SHALL BE PURCHASER’S SOLE AND EXCLUSIVE REMEDY.**

Super Chef makes no express warranties except as may be contained in this Limited Warranty concerning the manufacture and sale of its products. No modification or alteration of this Limited Warranty shall be made except by written document signed by an authorized representative or officer of the Company.

THIS WARRANTY IS EXPRESSLY IN LIEU OF ANY AND ALL OTHER WARRANTIES, EXPRESS OR IMPLIED, INCLUDING IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR PARTICULAR PURPOSE, AND ALL OTHER OBLIGATIONS OR LIABILITIES OF WHATSOEVER NATURE. ALL EXPRESS, IMPLIED OR STATUTORY WARRANTIES ARE EXPRESSLY EXCLUDED.

EXCLUSIONS

The Limited Warranty provided hereunder shall be void and shall not apply in the following circumstances:

- Where the component part or equipment is subjected to accident, damage, alteration, abuse, misuse or tampering.
- The defect or failure is due to circumstances beyond the control of Super Chef; the failure or defect is caused by the failure to follow the installation instructions pertaining to the equipment; the failure or defect is caused by the failure to follow the operating instructions pertaining to the equipment; or the failure to fill out and mail to the factory the warranty registration card, if applicable, within ten (10) days of the original installation date of the equipment.
